

Minutes for the PARISH COUNCIL MEETING held on Tuesday 10th October 2023 in St. Bartholomew's Church, Finningham, starting at 7:30pm

23.136 Visiting speakers

The meeting was chaired by Vice Chair Cllr Winter due to Cllr Kilbee's absence.

Cllr Mellen read through his District and County Councillor reports, which can be found as an addendum at the end of the minutes. Cllr Mellen also shared the Mid Suffolk State of the District Report 2023, which can be found as an addendum at the end of the minutes.

Mr Aiken read through his Footpath Warden's report, which can be found as an addendum at the end of the minutes.

23.141 To approve minutes of the Parish Council meeting held on 12th September 2023

23.143 Chairman's Report

23.144 Clerk's Report

- Reminder: NALC are working with The Parkinson Partnership LLP to update the 2019 model Financial Regulations for England and Wales. To help NALC with the update, they are seeking views on the technical aspect of the regulations by 5th November 2023, and the responses will inform the revision and content of these regulations. Deadline to complete the form is 5 November 2023.
- SALC and SCC are running a free seminar called 'Getting to Grips with NSIPs' in Ipswich on 18th October 2023. The event is based on SALC and SCC's new guidance document on how town and parish councils can engage more effectively with the Nationally Significant Infrastructure Projects (NSIPs) process. Full details have been sent to councillors.
- MSDC have advised that Babergh and Mid Suffolk District Councils have received the Inspectors' Report on the Examination of the Babergh and Mid Suffolk Joint Local Plan 2018-2037. Full details have been shared with councillors.

 Cllr Charter has queried a modification to planning application DC/17/06190 Green Farm, Wickham Road, Finningham, IP14 4HT. The modification is to remove the affordable housing element, but a consultation request has not been sent to the Parish Council. The Clerk has contacted the Planning Officer for further details and to query why the council has not been asked to comment.

ACTION – Clerk to advise councillors once a reply has been received from the Planning Officer, as above.

23.145 Finningham GREEN Footpath update

Suffolk Highways have advised that their utility search has confirmed that there are both BT and Suffolk & Essex Water utilities below the proposed footpath. They therefore need to dig a trial hole to ascertain the depth of these services, and lower the BT chamber adjacent to the village sign so the level matches the level of the existing footpath. This means there will be an additional £2,256.00 of design costs, which Cllr Mellen has kindly agreed to fund from his Highways budget.

23.146 Annual Newsletter update

No update. Cllr Trew said he needs details of the printing requirements in order to obtain quotations. Cllr Kilbee has previously advised that the member of the public assisting with the newsletter is providing one quotation, so two comparable quotations are required as per FR 10.3. **ACTION – Clerk to request printing details from Cllr Kilbee to send to Cllr Trew**

23.147 Churchyard Maintenance update

The Clerk has sought advice from SALC (Suffolk Association of Local Councils) and NALC (National Association of Local Councils) regarding the legality of the NALC LTN (legal topic note) stating the PCC has responsibility to hand over the churchyard in a good state of repair. SALC's Cemetery Advisor has said that although there is an expectation that the PCC would hand over the churchyard in a good state of repair, unfortunately good practice, fairness, and reasonableness in this context are not legal requirements. They also advised that the Clerk should have seen a copy of the closure Order of the churchyard. This was not shared by the PCC at the time of their request for the Parish Council to take over maintenance of the closed churchyard, so the Clerk has asked to see a copy. To be discussed further once the closure Order has been seen.

ACTION - Clerk to pursue copy of the closure Order as above

Cllr Winter has looked at replacement cabinets which are approximately £550 plus VAT. However, they all appear to use the same brand of lock, and as it is the lock which is the issue it would be preferable to have a different brand. Cllr Trew said he will have a look at the cabinet and lock, to see if it is possible to change the lock only, using a different brand.
